## **Purpose of Inspection**

The RHRA received a report under section 75(1) of the Retirement Homes Act, 2010 (the "RHA").

#### **NON-COMPLIANCE**

1. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 73; Procedure for complaints to licensee.

Specifically, the Licensee failed to comply with the following subsection(s):

<u>73. (1)</u> Every licensee of a retirement home shall ensure that there is a written procedure for a person to complain to the licensee about the operation of the home and for the way in which the licensee is required to deal with complaints.

## **Inspection Finding**

The home did not follow the Licensee's complaint policy.

#### **Outcome**

Corrective action taken by the Licensee.

2. The Licensee failed to comply with the RHA, S.O. 2010, c. 11, s. 67; Policy to promote zero tolerance.

Specifically, the Licensee failed to comply with the following subsection(s):

<u>67. (4)</u> Without in any way restricting the generality of the duties described in subsections (1) and (2), the licensee shall ensure that there is a written policy to promote zero tolerance of abuse and neglect of residents and shall ensure that the policy is complied with.

## **Inspection Finding**

Without in any way restricting the generality of the duties described in subsections (1) and (2), the Licensee failed to ensure compliance with the written policy to promote zero tolerance of abuse and neglect of residents.

### **Outcome**

Corrective action taken by the Licensee.

3. The Licensee failed to comply with O. Reg. 166/11, s. 43; Initial assessment of care needs. The Licensee failed to comply with O. Reg. 166/11, s. 44; Full assessment of care needs. The Licensee failed to comply with O. Reg. 166/11, s. 47; Development of plan of care.

Specifically, the Licensee failed to comply with the following subsection(s):

- **43. (1)** Subject to section 45, no later than two days after a resident commences residency in a retirement home, the licensee of the home shall ensure that an initial assessment of the resident's immediate care needs is conducted.
- <u>44. (1)</u> Subject to section 46, no later than 14 days after a resident commences residency in a retirement home, the licensee shall ensure that a full assessment of the resident's care needs and preferences is conducted.
- <u>47. (2)</u> No later than 21 days after a resident commences residency in a retirement home, the licensee of the home shall develop a complete plan of care for the resident based on the full assessment of the resident's care needs and preferences conducted under section 44 that takes into account all of the matters that must be considered in a full assessment.

## **Inspection Finding**

The Licensee failed to ensure that no later than two days after a resident commenced residency in a retirement home that an initial assessment of the resident's immediate care needs was conducted. Further, the Licensee failed to ensure that no later than 14 days after a resident commenced residency in a retirement home that a full assessment of the resident's care needs and preferences was conducted. Furthermore, the Licensee failed to ensure that no later than 21 days after a resident commenced residency, that a complete plan of care for the resident based on the full assessment of the resident's care needs and preferences conducted under section 44 was developed.

#### **Outcome**

Corrective action scheduled to be completed by the Licensee by March 30, 2015.
